

RESOLUTION OF 12 SEPTEMBER 2022 OF THE UNIVERSIDAD COMPLUTENSE DE MADRID, PUBLISHING THE LIST OF CANDIDATES ON THE RESERVE LIST WHO OBTAIN THE STATUS OF BENEFICIARIES IN THE SECOND CALL FOR UNA4CAREER POSTDOCTORAL FELLOWSHIPS.

In view of the resignations to the status of beneficiary presented by the applicants included in the list that appears as ANNEX I in this resolution, and in accordance with points 6.1.2 and 7.1 of the second call for postdoctoral fellowships of the UNA4CAREER programme (Resolution 26 May 2021, BOUC 3 June 2021), this Rectorate

## **RESOLVES**

to order the publication on the UCM website (UNA4CAREER programme website and the European Office for R&D website) of the list of candidates on the reserve list who obtain the status of beneficiaries due to the aforementioned resignations (ANNEX II).

The date of incorporation of the beneficiaries listed in ANNEX II to their department of assignment will be 12 December 2022, subject to obtaining the relevant ethical permits in accordance with the provisions of the text of the call, and without prejudice to the fact that for reasons beyond the control of this Rectorate or the beneficiaries it may be necessary to delay it.

The beneficiaries listed in ANNEX II may request an extension of the date of incorporation for a maximum of 3 months. To this end, the request for extension must be accompanied by a reasoned report signed by the corresponding researcher tutor, as per ANNEX III. The applications must be submitted together with the reasoned reports within 45 calendar days from the day following the date of publication of this Resolution to the European Office for R&D (U01000375), through the General Registry of the UCM, in its auxiliary registries, or in the manner established in Article 16 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations.

An appeal for reinstatement may be filed against this Resolution before this Rectorate, which exhausts the administrative process, within a period of one month, as from the day of its publication (articles 112, 123 and 124 of Law 39/2015, of 1 October, on the Common Administrative Procedure of Public Administrations). Otherwise an administrative contentious appeal may be filed within a period of two months, as from the day following the publication of the aforementioned Resolution, before the Court of Contentious-Administrative Law of Madrid (articles 8.3 and 46.1 of Law 29/1998, of 13 July, regulating the Contentious-Administrative Jurisdiction).
